**ORDER:**

Visakha Institute of Medical Sciences has been established with the following objectives:

- To bring health care excellence in the State of Andhra Pradesh.
- Compliment government supported health insurance schemes through strengthening of public sector institution such as VIMS.
- To promote good quality clinical care benchmarked with international standards thereby making VIMS world class health city.

2) In support of these objectives and for effective management of VIMS, the Government hereby constitute the Governing Body with the following composition for devising strategic plan along with its annual deliverables which shall be approved by a Governing Body:

1. Principal Secretary (HM&FW) – Chairperson.
2. District Collector (Visakhapatnam) – Member
3. Vice Chancellor (Dr.NTRUHS) – Member
4. Advisor (Health), Govt. of Andhra Pradesh – Member
5. CEO, NTR Vaidya Seva – Member
6. Director of Medical Education (Administration) – Member
7. Director (VIMS) – Member Secretary

3). Terms of reference (TOR) of the Governing Body:

- The Governing Body of VIMS shall meet at least once in three months or as and when required.
- The Governing Body shall approve the strategic plan for development of VIMS, recommend its budgetary and human resource requirement and recommend such steps so as to meet the desired institutional objectives.
- The Governing body shall recommend such steps to as to ensure development of VIMS as a robust public sector institution with its administration via establishment of suitable administrative structure such as Public Sector Trust / Public Sector Society / Public Sector Enterprise, as may be suitable, well complimented with appropriate operational modes such as Public Private Partnerships / Annuity as appropriate.
- In such cases, the members of Governing Board shall be the Trustees / members of the registered body as may be established.
- It shall be endeavoured to make VIMS a successful model with centers of clinical excellences through partnerships with renowned national & international institutions. Such collaborations shall be made to augment capital resources, clinical excellence and scope of services. VIMS shall endeavour to provide good quality, affordable healthcare to the people of Andhra Pradesh and to become a reputed healthcare institution globally.

4) The Director, VIMS/ Director of Medical Education, AP shall take necessary action in the matter accordingly.
